Fairview Park Master Plan Update

Results from 11/18/2025 City Council Meeting

It was amazing to see so many people come together to fight for the future of Fairview Park! 155 people wrote in!!! That sort of response goes to show where the community is at on this issue. It's heartbreaking, though, to see HSS continue to be targeted and bullied by a small group of individuals and organizations. You can watch the meeting at the link below.

Here's an update from Tuesday's Costa Mesa City Council meeting:

- 196 written public comments were submitted.
- 155 of those comments OPPOSED the draft Fairview Park Master Plan Update!
- 29 comments were in favor of the plan.
- The remainder were indeterminable.

Thank you to everyone who wrote in! Your voices made a difference. These numbers were actually discussed by the Councilmembers at the meeting.

Unfortunately, the meeting ran late (11:40 pm), and the Council decided to pause the discussion. They'll consider everything further and make a motion to vote on the matter at the next Council meeting on Dec. 2, 2025.

What does this mean? The Council hasn't voted yet, so they're still weighing their decision. That means we have a window to sway their opinion! Please don't hesitate to reach out to a Councilmember. Whether it's sending an email, having a conversation, or encouraging others to speak up, your voice still matters. Email instructions are in the sections below.

We need continued support if we want to preserve Fairview Park and stop significant changes that would eliminate:

- Concerts in the Park
- Bike access and paths
- The flying field
- The dirt mounds
- Dog walking
- Walking trails
- The trains

The flying field issue is being used as a Trojan horse to push for changes that go against the intent of Measure AA. Check out HSS' (<u>Harbor Soaring Society - HSS</u>) recent Facebook posts for more background information.

Subject: I do NOT support the Draft Fairview Park Master Plan Message (you can copy and personalize):

Mayor, Mayor Pro Tem, Councilmembers,

I do not support the current Draft Fairview Park Master Plan. Please make major changes so the community can continue long-standing uses at Fairview Park. The Plan should explicitly preserve the model glider field in its current location, Concerts in the Park, bicycle and dogwalking trail access, the dirt mounds, and the Goat Hill Junction Railroad — and direct staff to work with the resource agencies on an approach that allows these uses to continue safely and compliantly.

I also do not support any new fencing that reduces public access. Any revision should honor the community intent of Measure AA and protect the existing open, shared character of the park.

If the Draft Master Plan cannot be revised to reflect the community's uses and expectations, then the City Council should consider canceling the Master Plan Update and retaining the existing 2008 Fairview Park Master Plan.

Fairview Park should remain a shared space that protects sensitive wildlife and continues to provide room for people, families, and community activities.

The TRUST Test and FAA Registration

TRUST is <u>The Recreational UAS Safety Test</u>. It provides education and testing for recreational flyers on important safety and regulatory information. If you fly your drone recreationally under the <u>Exception for Recreational Flyers</u> you must pass the test before you fly. To take the test, go to http://trust.modelaircraft.org. This is the AMA Site. Take the test (Don't worry, it is fail proof) then obtain your "Completion Certificate."

All recreational flyers must pass this aeronautical knowledge and safety test and provide proof of test passage (the TRUST completion certificate) to the FAA or law enforcement upon request.

Go to http://faadronezone.faa.gov and create an account for your FAA Registration. Apply for "I fly under The Exception For Recreational Flyers". They will issue you an FAA registration number that must be affixed to the outside of all of your radio control model aircraft. The charge is \$3 for three years, for all of your R/C aircraft.

All recreational flyers must pass this aeronautical knowledge and safety test and provide proof of test passage (the TRUST completion certificate) to the FAA or law enforcement upon request.

Go to http://faadronezone.faa.gov and create an account for your FAA Registration. Apply for "I fly under The Exception For Recreational Flyers". They will issue you an FAA registration number that must be affixed to the outside of all of your radio control model aircraft. The charge is \$3 for three years, for all of your R/C aircraft.


