-PRESIDENT'S CORNER-

Join the LSF...the League of Silent Flight. "The LSF provides a realistic challenge to the R/C soaring enthusiast through a series of meaningful standards of flying proficiency...goals



that can be attained at most local flying sites. Membership in the League can only be earned...by personal, documented performance. Membership does not require Dues or Fees." A quote from Le Gray, some years ago. The LSF five level achievement program is patterned after that of the prototype full scale soaring Silver "C", Gold "C", Diamond "C" program where each "C" goal is progressively more difficult to attain. The first two levels require a series of precision spot landings, then landings are no longer needed except as a part of contest requirements. The thermal duration times start at five minutes at level 1 to two minutes at level V. The goal and return requirement start at level 111 with one kilometer(this can be done at our regular flying field) level 1V is two kilometers and level V is ten kilometers. Both of these will probably require a chase vehicle to keep up with the glider. A medium performance model glider can attain a glide angle of fifteen to one. Starting from a one thousand foot winch tow, traveling crosswind, this medium glider should be able to make three kilometers (one and one half out, one and onehalf back) without thermal help. Here in California, the logical site for long range attempts would be El Mirage Dry Lake which is northeast of Lancaster. This dry lake is quite suitable for auto chase in any direction and this area is well known for its thermals because the full scale soaring pilots use it regularly. Gus Begrieb has his glider factory and school at this dry lake for full scale gliders. the remaining requirements for the LSF program are six contests for each level, a certain number of contests points for each level, and to keep the top level tough, three contest wins, (first place) are required over twenty pilots or more entrants per contest. This is one reason we like to have our monthly contests attendance above twenty piolts each. The Beginning levels of the LSF do not require this many entrants and as the club paper

from the Valley Flier pointed out last month, the LSF contests do not have to be official Club Sweepstakes events. The L will accept any contest where decent recordare kept, in other words, a Contest Direct willing to do the work. Here comes the need for volunteer labor again. The Editor of the club paper will be glad to report the resulof any LSF contest in the paper and any officer of the Club will be willing to comersign as a witness for any LSF contest held in his presence.

What are the ingredients of a contest? Most contests are variations and combinations . of the three tasks permitted by the physics of nonpowered flight. These are duration, time, and landing accuracy. Two other basic types of task are not popular anymore because of the judging manpower or specialized equipment required. These are aerobatics and altitude. The time events include time around a known course, time to land(precision landing) and the variations that combine time with duration. Time is usually limited to prevent a lucky pilot from using up most of the day on one flight The second ingredient needed is someone to reduce the contest idea to practise up a scoring system, bring out the proper equipment to the field, and keep records. Here comes the volunteer Contest Director again, without him nothing happens. The third ingredient is recognition. There was a time when a list of entrants and place standing published in the club paper was enough. The LSF program is another form of recognition. Hardware in the form of merchandise, and trophies are a form of recognition, but by no means vital for recognizing who did what last month. Our most elaborate form of recognition is the Sweepstakes Trophy for the year which is a summary of all the effort for a whole years season. Most of our meeting discussions in the past concerning contest have stuck on the problem of wheather or not to recognize a particular contest (or event) as part of the Sweepstakes effort. It is not necessary to let the tail wag the dog when considering new events or contests. The recognition ingredient should not limit the type of contest or event held by or within our club That is why I have repeatly said in ir

discussions that any experimental contest can
be done easily and for fun as long as you do
it make it a part of the Sweepstakes and


