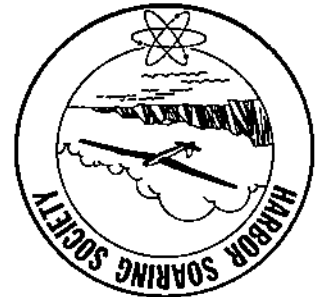

SEPTEMBER THERMAL CONTEST

The September contest will be a thermal contest with the emphasis on thermaling with a fun twist. It will be 3 flights for 18 minutes, landing on the exact minute, called by the pilot, while in flight. A 50 foot landing tape with 10 foot markings for 100, 80, 60, 40, 20 points per landing. Landing in the mowed "normal" landing area will be worth 10 points. A optional one loop per flight will each be worth 1 minute off the total 18 minute flight time (flight time will stop when model comes to rest.) Scoring details will be discussed at the September club meeting.
