Selected minutes from the November 23, 2002 City of Costa Mesa Fairview Park Master Plan Reconfirmation workshop.

This meeting was to be over four hours long, and to document all issues addressed is not the subject here. As modelers, we are concerned with the city council and their comments and approval of continued flying access at Fairview Park. Many and varied issues were heard, and some approved while others, such as a dog park, a botanical garden, a pond, and flying gas-powered RC planes in the park were removed from further consideration. It is noted that the main petitioner of gas-powered aircraft was not in attendance. It was also noted that approximately 25 modelers were in attendance at the meeting. Good show! Lets keep up the presence at these meetings to demonstrate to the city we are responsible users of the park.

Councilwoman Libby Cowan states early in the meeting "only gliders, no electrics". She later changes her position to include electrics. She may have been confused on the issue.

Jan Van der Sloot (person working on restoring the natural elements in the park) mentioned "motorized gliders" and appears to be somewhat opposed to them. HSS would be advised to talk-out concerns with Mr. Van der Sloot and work together with him.

One other complaint was made in regards to motorized gliders as that person felt that they caused pollution and noise.

Karl Hawley, President of the Harbor Soaring Society addressed the council and mentioned the fact that HSS has used the site for 30 years now, and 20 of those years include electric aircraft. He states that most flyers have AMA insurance that provides coverage of \$2.5 million. Further, as a club, HSS has not left a "mark in the park", demonstrating that we are environmentally sensitive to the use of the park. In essence, we are an advocate or good neighbor. Good comments Karl!

Mr. King from the Swan Drive area that faces the park stated that he and his wife have coffee in the mornings and watch the gliders fly. He further stated that "They are great!" This is from an unbiased source. Thank you Mr. King.

Our resident world champion pylon racer speaks of growing up using the park and learning to fly here. He states that HSS makes good use of the park. We appreciate Troy's positive comments.

Ron Molendyke, the master plan administrator was asked what the city staffs position on flying in the park was and he stated that electrics and sailplanes were OK.

With concerns on how to better work with HSS, councilwoman Karen Robinson asked for the vote on use of the flying site to be postponed for two weeks. She decided to visit the site and evaluate noise and safety issues for herself.

### Councilperson Robinson Visits Fairview Park

On Saturday November 23, 2002, Costa Mesa City councilwoman Karen Robinson visited Fairview Park. At the Fairview Park Master Plan Reconfirmation Workshop held previously on Monday November 18, 2002, councilwoman Robinson believed that there was room to debate the nature and types of RC aircraft flying in the park. At that time, she asked to postpone the vote on the types of uses that would be allowed and further stated that she would tour the park on the following Saturday and evaluate the flying.

Councilwoman Robinson walked into the flying area of the park around 9:45 am and was greeted by HSS president Karl Hawley. She spoke with and heard the concerns of many fliers. After hearing varied viewpoints from many of the Saturday regulars, (including one flier whom none of us were familiar with), councilwoman Robinson appeared to be mostly interested in several issues. How we can have a shared use of the park so as not to interfere with others who might be using the park at the same time, flying and landing safety, and how the city and HSS can work together. She was also interested in keeping the traditional areas used by HSS in a natural state and working to foster a good working relationship between the city and HSS.

After touring the site with several members of HSS, councilwoman Robinson determined that this issue requires more thought and addressing it in a city council study session would be a better way to clarify allowed uses (re: sailplanes and electrics).

Fellow HSS members, here is where we can all make a difference. Lets get organized with a single view point and the attitude that working with the city to focus on safety issues, noise levels, and flight safety are good for everyone. HSS has a long and reputable history and is known as being the oldest sanctioned AMA flying site in the country. Lets focus on fostering a good working relationship with the city. Flying electrics north of the school will mitigate the noise concerns and using established rules, flight safety is addressed. Lets use some common sense here. The city has been gracious enough to allow HSS to continue flying in the park since they purchased the land from the county and they have included us in the parks master plan. It is time for each of us to step up to the plate and act responsibly. A thank you to those of you who already do so. Lets not only keep a flying site, but instead, lets work with the city to create a really great flying site that addresses the needs of electrics and sailplanes and the safety issues involved. This is the only way to achieve our mutually desired goals. As the first act of a good neighbor, and in his never-ending ambition to recruit another flyer, Karl gave councilwoman Robinson her first training flight and a hearty invitation to return anytime for more flight training. Let us look at this example and be good stewards now so that we can enjoy the park for many years to come, so that the next generation also has a beautiful, pristine, and natural flying site to enjoy in the future.

The next regular club meeting will be on January 7, 2003. (The Christmas banquet will be the meeting for December.)


The January club Contest well be on January the 5<sup>th</sup>. It may be a 4 round 10 minute format contest.

# Owl knocks railroad enthusiasts off schedule

### FYI

- ► The western burrowing owlhas a slightly misleading name, as it seldom digs its own burrow but prefers to use the vacated burrows of small animals like prairie dogs and ground squirrels.
- ▶ It is endangered in Canada, Mexico and in the states of Minnesota and lowa. It is designated as a "species of special concern" in six other states, including California.
- The burrowing owl is approximately 9 inches tall and weighs up to 6 pounds. They have a rounded head, lack ear tufts, but are easily distinguishable by their white eyebrows, bright yellow irises and long stilt-like legs. Their plumage is a mottled brown and white coloring:

- ▶ Unlike most owls, the burrowing owls are active both day and night, especially during dawn and dusk.
- Burrowing owls feed on small rodents, reptiles and insects.
- ▶ Out of 171 species of owls worldwide, it is the only one that lives in burrows.
