Please make fundamental changes to the Plan in order to ensure long-standing community uses at Fairview Park, including the model glider flying field in its current location, Concerts in the Park, bicycle and dog-walking trail access, the Goat Hill Junction Railroad and other community uses continue into the future.

I support a plan that keeps existing operations in place and directs staff to work with Resource Agencies and community stakeholders to provide a balanced solution that does not remove park amenities.

The current Fairview Park flying field has operated safely and cooperatively for 27 months since it re-opened in July of 2023. This community resource has been in this location for 61 years. Please help us keep it!

The Fairview Park Master Plan Update Draft is the only item on the agenda. You may speak in person or on Zoom. Arrive early and keep comments to three minutes, factual, and respectful. Even 10–15 consistent voices can make a big difference. Please show up!

#### Talking points (choose a few):

- Use your opportunity to speak to tell a personal, positive story related to the flying field or something HSS has done for the community.
- HSS is a 501(c)(3) non-profit, AMA-chartered club since 1964, with 61 years at Fairview Park.
- HSS flyers have followed the flying field rules diligently for 27 months of cooperative operations.
- Over 780 free public flight lessons given in the past 27 months.
- Federal USFWS letters (2014 and 2019) support coexistence, not relocation.
- Current location is safest and most accessible, with existing power, parking, and ADA access.

- Measure AA and the 2008 Master Plan recognize glider flying as a compatible passive use.
- HSS promotes STEAM education and environmental stewardship for the community.

## The TRUST Test and FAA Registration

TRUST is <u>The Recreational UAS Safety Test</u>. It provides education and testing for recreational flyers on important safety and regulatory information. If you fly your drone recreationally under the <u>Exception for Recreational Flyers</u> you must pass the test before you fly. To take the test, go to <a href="http://trust.modelaircraft.org">http://trust.modelaircraft.org</a>. This is the AMA Site. Take the test (Don't worry, it is fail proof) then obtain your "Completion Certificate."

All recreational flyers must pass this aeronautical knowledge and safety test and provide proof of test passage (the TRUST completion certificate) to the FAA or law enforcement upon request.

Go to <a href="http://faadronezone.faa.gov">http://faadronezone.faa.gov</a> and create an account for your FAA Registration. Apply for "I fly under The Exception For Recreational Flyers". They will issue you an FAA registration number that must be affixed to the outside of all of your radio control model aircraft. The charge is \$3 for three years, for all of your R/C aircraft.

All recreational flyers must pass this aeronautical knowledge and safety test and provide proof of test passage (the TRUST completion certificate) to the FAA or law enforcement upon request.

Go to <a href="http://faadronezone.faa.gov">http://faadronezone.faa.gov</a> and create an account for your FAA Registration. Apply for "I fly under The Exception For Recreational Flyers".
