February 2nd: Thermal Duration contest. Tom Copp will be the CD. What does he have in store for us? Come and see.



FAIRVIEW PARK MASTER PLAN: A GUIDE FOR TOMORROW

The Fairview Park Master Plan was established as a dynamic plan so its progress could adapt to the needs of the park and the community. With the recent news that the park had been selected by a burrowing owl for it's nesting grounds, the master plan was significantly altered since its last revision. Several designated areas have been removed from the plan based upon our local resident owl, the railroad track expansion, and input from the public workshops.

Orange County Model Engineers Expansion Approved By City Council -The Orange County Model Engineers submitted a request for and received approval of an amendment to the Fairview Park Master Plan. The amendment is to allow an additional 2,250 lineal feet of railroad track that will be added to the Model Engineers' existing 8,800 lineal feet of track on the eastside of Placentia Avenue. The approved project is a logical extension of the current track system. The requested extension received approval by the Planning Commission on October 15, 2002, and by the City Council at their November 18, 2002 meeting. It is anticipated that installation of the new track will start in early 2003.

City Council Re-Confirms Fairview Park Master Plan - At the request of City Council, staff held two public workshops on July 11, 2002 and August 15, 2002 on

the Fairview Park Master Plan in order to receive input by the community. It was apparent from the feedback that the majority of the public desired a "passive park." The workshops offered the opportunity for the elements within the Master Plan to be discussed in detail between staff and members of the community and users of the Park. A comprehensive report prepared by City staff was forwarded to the Parks and Recreation Commission, as part of the public hearing process to accept further input on the Master Plan.

At the City Council meeting of November 18, 2002, the recommendations of the Parks Commission, City staff, and the public were given careful consideration. After a lengthy discussion, City Council reconfirmed the following Master Plan Elements: Model Railroad, Museum/Multi-Purpose Building, Parking Lot- Eastside, Trails, Nature Habitat, Vernal Pools, Interpretive Area, Neighborhood Park, Model Airplanes (Glider & Electric), Picnic Areas and Restrooms, and Areas A, C, D and E per Master Plan. Elements Deleted: Dog Park, Pond, BMX, Botanic Gardens, Parking Lot (northwest lowlands), Huscroft House. Now that the elements have been adopted by the City Council, implementation will move forward.

Join us for our series of tours that display the variation of the



BURROWING OWL

Athene cunicularia




A lone burrowing owl retreats to the east side of Fairview Park from December to March and vacations in an abandoned squirrel hole. The burrowing owl is a yearlong resident of open, dry grassland and desert habitats. They are also found as residents in grass, forb

and open shrub stages of pinyon-juniper, and ponderosa pine habitats.

The long legs distinguish this ground-dwelling owl from all other small owls. They are small owls of open country and are often seen by day standing erect on the ground or on posts. They measure 9 to 11 in (23 to 28 cm), about the size of a screech owl. The adult is boldly spotted and barred, whereas, the juvenile is buffy below. The males tend to be paler in color and proportionately larger in size than the females.

The head is rounded, there are no ear tufts, the eyes are yellow, they have whitish eyebrows, a white chin stripe, and the tail is short. When agitated, the head bobs or the owl bows



Although these owls are often considered to be diurnal, they are almost entirely nocturnal, or at least crepuscular (active at dawn and dusk). They are generally considered to be diurnal because they frequently perch conspicuously during daylight hours, especially early morning and late afternoon, at or near the entrance to their burrow or on a nearby low post. During the period when they have nestlings or recently fledged young, one or both owls are usually perched on guard very near the entrance to the nest burrow.

This ground owl preys mostly on insects, small mammals, reptiles, birds, and carrion. This owl usually hunts day and night from a perch; then hovers, displays hawk dives, and hops after prey on the ground.



The male conducts his courtship display in front of the burrow. Actual breeding occurs anywhere from March through August and the clutch size is two to ten. The young emerge from their burrow at approximately two weeks and are flying by about the fourth week.

This owl usually nests in the old burrow of a ground squirrel, badger, or other small mammal, although they may dig their own burrow in soft soil. The actual nest chamber is lined with excrement, pellets, grass, feathers, and other debte, but semetimes is unlined. Where

debris, but sometimes is unlined. Where burrows are scarce, pipes, culverts, and a even nest boxes may be utilized.

Conversion of grasslands to agriculture, other habitat destruction, and poisoning of ground squirrels, has contributed to the reduction in numbers of owls in recent decades. Some of their predators include a prairie falcons, red-tailed hawks, Swainson's hawks, ferruginous hawks, northern harriers, golden eagles, foxes, coyotes, and domestic dogs and cats.
