

We will have hosted the Leisure contest by the time you read this, and we will have our first thermal contest on March 6th.

I wish to extend a HUGE thank you to all the membership for your patience and understanding in our problems dealing with the insurance, and Use Permit problems.

# THERMAL CONTEST FOR MARCH

This contest will be flown as follows: Three rounds of 5 min. duration, 900 pts.on flight time, 100 points landing. Standard 25° landing tape will be used. Three points will be subtracted from the 900 possible flight points for each second under the prescribed 5 min. flight duration. THIRTY points will be subtracted from the possible 900 flight points for each second OVER the prescribed 5 min. flight duration.

There will be a CALLED FLIGHT ORDER. If you are called to fly and do not report to the winchmaster within 2 mins. you will receive a ZERO for that round.

ALL landing approaches WILL be from the NORTH or EAST into the landing area. Any landing approach over the launch area or over the pit area will disqualify the flyer from that round.

The contest will start at 9:00 am. If you are called to fly at 9:00 you must be on the winch before 9:02!!

AMA and FCC licences are required.

The contestants will be divided up into three classes, determined by their experience level: EXPERT, ADVANCED, or SPORTSMAN.
