DUES FOR 1984

At a board of directors meeting it was decided that the following dues will be charged by the club in 1984:

IF A MEMBER IN GOOD STANDING FOR 1983 RENEWS HIS/HER DUES BEFORE OR AT THE CLUB MEETING IN FEBRUARY 1984, AND HAS BEEN CLASSIFIED AS A SENIOR MEMBER (17 YEARS OLD OR OLDER AT THE TIME OF RENEWAL) THE FEE WILL BE \$15.00.

IF A MEMBER THAT IS CLASSIFIED AS A SENIOR MEMBER, 17 YEARS OLD OR OLDER, DOES NOT RENEW HIS/HER DUES BEFORE OR AT THE FEBRUARY 1984 CLUB MEETING, THEY WILL BE DROPPED FROM THE ROSTER AND THEY WILL BE CHARGED THE SAME FEE AS A NEW SENIOR MEMBER WHEN OR IF THEY REAPPLY FOR MEMBERSHIP.

THE FEE FOR A NEW SENIOR MEMBER, 17 YEARS OLD OR OLDER, WILL BE \$18.00. THIS WILL COVER THE COST OF THE CLUB NAME BADGE, PATCH, AND DECAL.

JUNIOR MEMBERS, 16 YEARS OR YOUNGER AT THE TIME OF APPLICATION OR RENEWAL WILL PAY A FEE OF \$6.00.

FAMILY MEMBERSHIP: A SECOND (OR THIRD, ETC.) AMA MEMBER RESIDING AT THE SAME ADDRESS AS A MEMBER IN GOOD STANDING OF HARBOR SOARING SOCIETY, MAY ALSO JOIN THE CLUB BY PAYING A MEMBERSHIP FEE OF \$4.00 PER EACH ADDITIONAL APPLICANT.

Obviously you are encouraged to reapply for membership as soon as possible. Financially you can see the cost saving of early renewal. A membership application is included in this newsletter. 
